In 1996, I provided psychological assessment services to approximately 100 patients scheduled for vertical banded gastroplasty. My responsibilities included conducting intake interviews with each patient and the administration, scoring, and interpretation of the MMPI-2.

Since 1998, I have been exposed to multiple clinical areas, multiple clinical environments, and have worked with clients from various age groups and ethnic backgrounds. I have worked with clients with social and intellectual deficits. I have provided psychological services in four different federal penitentiaries (i.e., the Regional Reception and Assessment Center [multi-level security], Matsqui Institution [medium-security], Mountain Institution [medium-security] and Kent Institution [maximum-security]) and in two Parole offices in the community (i.e., Vancouver Parole, New Westminster Parole) governed by the Correctional Service of Canada. The majority of my correctional clinical experience was conducted at Mountain Institution and Kent Institution. Mountain Institution contains only protective custody inmates. Kent Institution, the only strictly maximum-security institution in BC, contains both protective custody and general population inmates, in addition to a unit that contains approximately 30 inmates that cannot be safely housed in the protective custody population (i.e., the Alternative Housing Unit). Since working at Kent Institution as a Psychological Associate, I have provided psychological services to over 350 inmates. Since commencing employment for the Forensic Psychiatric Services Commission (FPSC) in 2006, I have provided psychological services to mentally disordered patients at the Forensic Psychiatric Hospital (e.g., assessments focused on malingering, diagnostic clarification, personality/personality pathology, cognitive functioning, neuropsychological screening; treatment regarding developing, implementing, and supervising behavioral modification programs, cognitive behavioural therapy for anxiety, depression, psychosis, substance abuse).
